No.44-Leg./2013- The following Ordinances of the Governor of Punjab promulgated under clause (1) of article 213 of the Constitution of India on the 16th Day of august, is hereby published for general information:-

THE PUNJAB SCHOOL EDUCATION BOARD (AMENDMENT)

ORDINANCES, 2013

AN

ORDINANCE

Further to amend the Punjab School Education Board Act, 1969.

Promulgated by the Governor of Punjab in the Sixty-fourth year of the Republic of India.

Whereas the Legislative Assembly of the state of Punjab is not in session and the Governor is satisfied that circumstances exist, which render it necessary for him to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of article 213 of the Constitution of India, the Governor of Punjab is pleased to promulgate the following Ordinance, namely:-

1. This Ordinance may be called the Punjab School Education board (Amendment) Ordinance

2. It shall come into force on and with effect from the date of its publication in the Official Gazette.

2. In the Punjab School Education Board Act, 1969, in section 17, after sub-section (1), the following subsection shall be inserted, namely:-

"(I-A) No other authority (by whatever name it may be called), except the Board, shall be competent to perform the functions, as mentioned in clause (iii) of sub-section (1) of section 17 of this Act:

Provided that in authority, approved and authorized by the Government of India to which institutions situated in the State of Punjab are affiliated, shall be competent to perform the said functions.

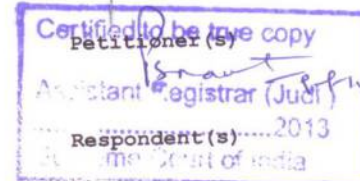
